

RANGE RULES, REGULATIONS & WAIVER OF LIABILITY

PROGRESSIVE COMBAT SKILLS TRAINING - RANGE ACTIVITY

Must be signed and followed by all who enter range to shoot and/or enroll in training courses

1. WEAPONS AND AMMUNITION BROUGHT INTO THE RANGE:

All firearms brought into the range must be completely UNLOADED, unless you are a concealed carry permit holder. If you do bring your carry weapon, let the Range Officer know, and he will clear you to proceed to the berm or safe area to clear your weapon prior to range and training operations. All weapons and ammunition are subject to inspection by the Range Officer for cleanliness, function, suitability and safety before entering the range.

A. PERMISSABLE FIREARMS:

- Fully automatic firearms are allowed at the discretion of the Range Officer with proper Class III paperwork - must be presented in advance.
- Shotguns are allowed at the discretion of the Range Officer, and with a briefing on target and ammo suitability.
- Air guns and BB guns are allowed.
- For firearms not mentioned here, check with the Range Officer prior to use on the range.

B. PERMISSABLE AMMUNITION:

- Standard commercial and reloaded ammunition in good condition is permitted.
- Any type ammunition designed for penetrating metal is not permitted.
- Steel jacketed, steel shot or steel core bullets are not permitted.
- Tracer, incendiary, gas or explosive ammunition are not permitted.

2. RANGE OFFICER:

- The Range Officer is in direct charge of the range and all participants at all times.
- The Range Officer has the authority to remove from the range any person handling a weapon in an unsafe or careless manner. The Range Officer may also terminate training if the actions of an individual endanger other participants.
- The Range Officer's judgments and decisions are final.

3. FIRING LINE PROCEDURES:

- *Always maintain muzzle discipline and keep your trigger finger properly indexed.*
- Make sure your hearing and eye protection is on before entering the range, and kept on at all times while on the range, unless authorized by the Range Officer.
- Keep your finger off the trigger until on target and ready to engage.
- Your weapon muzzle must be pointed down range and into the berm at all times.
- No weapon handling behind the firing line.
- *Always maintain muzzle discipline and keep your trigger finger properly indexed.*
- The Command of “CEASE FIRE” means...STOP SHOOTING, ASSUME LOW READY, and AWAIT FURTHER INSTRUCTION.
- ANYONE can call “CEASE FIRE” if an unsafe situation is observed.
- Shooters may perform immediate action drills to address a mechanical malfunction. If unable to correct the condition, keep the muzzle pointed down range and into the berm and consult with the Range Officer. DO NOT MOVE JAMMED OR MALFUNCTIONING FIREARMS away from the firing lane; contact the Range Officer immediately for assistance if unable to clear.
- No one is permitted forward of the firing line until authorized by the Range Officer by calling “RANGE COLD”
- *Always maintain muzzle discipline and keep your trigger finger properly indexed.*
- Do not bend down to pick up any fallen items or brass until instructed to do so by the Range Officer.

Unless specified in advance by the Range Officer:

- Only one loaded weapon on the firing line at a time.
- When leaving the firing line temporarily, clear your weapon and lay the firearm with the muzzle down range and the action open, or holster your weapon as range operations and the Range Officer dictate.
- Upon completion of shooting session, unload and clear your weapon(s) with the action opened.
- All brass is to be policed at the end of range or training session, and only when instructed by the Range Officer.

4. PERSONAL RESPONSIBILITY:

- Everyone is a Safety Officer – anyone can call “Cease Fire” for an unsafe condition.
- Only targets authorized by the Range Officer will be permitted – no exploding targets.
- Do not shoot target stands.
- All shooters will be held accountable and will pay for any damage you cause including replacement and installation charges.
- Do not shoot metal targets unless specifically briefed on safe operations by the Range Officer.

5. FIRING LINE OCCUPANTS:

- All persons utilizing the range are required to receive, understand and sign the rules, regulations and disclaimer and waiver of liability notice.
- All persons using the facilities and enrolling in training shall be of good character and be a US Citizen. A copy of a State Issued Driver’s License is required proof for training record-keeping.
- Progressive Combat Skills Training (PCST) reserves the right to refuse range service or training to anyone.
- Absolutely no consumption of alcohol prior to, or during range operations. Persons smelling of alcohol or who appear to be impaired will be required to leave the range.
- A responsible adult must accompany persons under twenty-one (21) years of age. This adult shall act as a coach, and MUST remain with the minor(s) at all times while the minor(s) utilizes the range.
- No food, chewing tobacco, snuff, or smoking allowed on the range.
- Only one shooter and coach permitted per firing lane.
- Persons not shooting, coaching, or assisting with scheduled training are not permitted on the range.

PLEASE ASK THE RANGE OFFICER IF YOU ARE NOT SURE!

Our goal is to make your training safe and effective. If anything in the instruction does not make sense, or you do not understand what the Range Officer or Instructor is asking you to do, ask a question before doing something that you think is unsafe, or that you are not capable of doing!

Help us keep this range safe. Please abide by the rules and help the Range Officer by keeping your eyes open and being situationally aware - After all, it’s the quality of your training and your well-being that we are concerned about.

Any and all visitors, guests, training attendees, or users of the Progressive Combat Skills Training (PCST) Range Facility and JW Reserve LLC, shall execute an agreement providing for the waiver and release of liability, and indemnification of JW Reserve LLC, in the following form.

I/We _____ hereby execute this Indemnification, Waiver, and Release Agreement (“Agreement”) on the date indicated below in favor of Progressive Combat Skills Training Range Facility and JW Reserve LLC, and their affiliates, parents, subsidiaries, directors, officers, employees and agents (collectively, “PCST”). I/We understand and agree to accept the risk of bodily injury and/or property damage which I/We may incur or cause a third party to incur as a result of my/our activities with PCST. I/We understand that this risk includes, but is not limited to, any lead dust inhalation, noise, airborne materials or objects, and the actions of other users of PCST’s services or facilities. I/we further agree to indemnify, defend, release, discharge and hold harmless PCST and its successors and assigns from and against any and all liability, claims, demands, suits or judgments of whatever kind or nature, either in law or in equity, including, but not limited to, claims for personal injury or property damage, arising from, or in connection with, my/our activities with PCST, including mere presence at a PCST facility. This agreement shall be binding upon my/our successors, assigns, heirs, executors and administrators, and any other person or entity(ies) who/which may have a claim based upon my/our personal injuries and/or property damage.

I/We understand that this release discharges PCST from any liability or claim that may exist against PCST with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my/our activities with PCST, whether caused by the negligence of PCST or otherwise. PCST does not assume any responsibility for or obligation to provide financial assistance or other

assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Furthermore, I/we have read and agree to abide by the rules and regulations pertaining to use of the PCST facility and acknowledge receipt of a copy of same. I/we understand further that I/we will be held financially responsible for any damage to facilities or equipment which occurs through use of the PCST Range Facility.

NOTE: by signing this form, I/We swear that the following representations are correct:

1. If under 21 years of age, you are accompanied by a parent or legal guardian.
2. You are not a fugitive from justice.
3. You are not an unlawful user of, or addicted to, marijuana or any depressant, stimulant or narcotic drug or controlled substance?
4. You have not been convicted in any court of a felony, or crime punishable by imprisonment for term exceeding one year, even if you were given a shorter sentence.
5. You have not been adjudicated mentally defective or committed to a mental institution.
6. You have not convicted in any court of a misdemeanor crime of domestic violence?
7. You are not subject to a court order restraining you from harassing, stalking or threatening an intimate partner or child of such partner?
8. You understand and agree to abide by the Range Rules and Regulations on Pages 1-3 of this document.
9. A copy of your driver's license (front and back) has been provided to PCST.

The adult user is responsible for the conduct of the Minor at all times, and Must enforce all range and safety rules.
